


That we, RICK MENTI and RAMEN HILL being, respectively, the President and

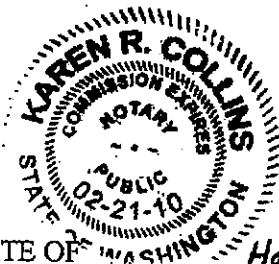

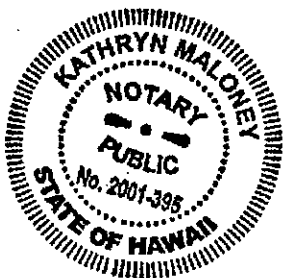

EXHIBIT A

**Amendment to Section 10(a) of the Restated Declarations
of Condominium Property Regime of Wailea Ekahi I, Wailea Ekahi II and Wailea Ekahi III**

A new subparagraph (vi) is added to Section 10(a) to read as follows:

(vi) Nothing in this Section 10(a) shall prohibit an owner from transferring, during the owner's lifetime or by a trust or testamentary instrument, an undivided interest in the owner's apartment to any lineal descendant of the owner. The term "lineal descendant" as used in this subparagraph (vi) shall mean a natural born or adopted child or grandchild of the owner. Provided, however, an undivided interest in any apartment acquired from a lineal descendant by any person who is not a lineal descendant of any owner of the apartment, shall be held and be subject to the terms and conditions of items (ii) through (v) of this Section 10(a).
